The Belgian-American soprano, Dr. Francisca Maxwell, was born in Argentina and grew up in Belgium. She studied at the Royal Conservatory in Brussels, department of the Erasmus Hogeschool, where she obtained a bachelor's and a master's degree in Vocal Arts with a certification in Vocal Pedagogy. She was a member of the Brussels Cathedral Choir (Cappella Sancti Michaelis) and the VRT National Radio Choir (Vlaams Radio Koor). She also participated on a regular basis in the early music vocal ensembles of La Petite Bande, Huelgas, Anima Eterna, Il Fondamento and Currende. In 1997, she was granted a Fulbright Scholarship by the Commission or Educational Exchange between the USA and Belgium and Luxembourg. With this scholarship, she continued her education at the University of Texas at Austin where she studied voice with Gilda Cruz-Romo and Nikita Storojev. She graduated as a Doctor of Musical Arts in Voice Performance in 2002.

Francisca started her professional career as a free-lance singer in Belgium, The Netherlands and Germany. Her performances have since taken her all over Europe, Russia and the USA. She was staged in leading roles of many operas and operettas, among which *L'Incorronazione di Poppea*, *Dido and Aeneas*, *Rinaldo*, *Alcina*, *Le Nozze di Figaro*, *Die Fledermaus*, *Eine Nacht in Venedig* and *Paganini*. She has been featured several times on public radio in the program "The Atlanta Music Scene." Francisca performed with the Georgia Institute of Technology Orchestra and Choir in <u>Felix Mendelssohn</u>'s *Lobgesang*, in Bach's *St John's Passion*, and in the *Requiem* by Jerry Ulrich. Since 2018, she forms a collaborative duo with concert pianist Dr. Elena Dorozhkina and they perform all over the southern United States.

Their recitals encompass music of diverse genres and style periods, but their love for Russian art song repertoire of the 19th and 20th centuries shines through in every program.

Francisca immigrated to Atlanta in 2009 where she built a thriving private studio. She held a position as artist affiliate at Agnes Scott College in Decatur, Georgia. In the fall 2018, she joined the faculty at Clayton State University in Morrow, Georgia as Lecturer in Vocal Studies. Besides voice lessons, she teaches Music Appreciation, World Music and subjects related to vocal performance and pedagogy. Upon the revival of the Delta Psi chapter at Clayton State in 2021, she became a member of Mu Phi Epsilon and has been the faculty advisor for Delta Psi since then. The Professional Fraternity Association named her "Faculty Advisor of the Year" in 2022. She lives with her husband in Decatur, GA.

BIOGRAPHY: Tenor Kurt-Alexander Zeller (Mu Chi, Atlanta Alumni) is Coordinator of the Division of Music and Director of Opera and Vocal Studies at Clayton State University in metropolitan Atlanta. He has sung across North America and Europe in all forms of music drama, as well as in concert and early music, and has staged many operas, ranging from Monteverdi to Menotti, for both professional and academic stages. His 2008 production of Benjamin Britten's Noye's Fludde in collaboration with the Clayton County Public Schools was profiled by Opera America as an example of excellence in opera education, and his 2022 film of Bruce Trinkley and Jason Charnesky's opera for children, The Prairie Dog that Met the President, was an award winner at the 2023 Nature Without Borders International Film Festival.

A licensed instructor with the Association for Body Mapping Education (www.bodymap.org), Dr. Zeller has presented for the International Congress of Voice Teachers, national and regional conferences of the National Association of Teachers of Singing, the National Opera Association, the National Association of Pastoral Musicians, and Early Music America. With Melissa Malde and MaryJean Allen, he is co-author of the book What Every Singer Needs to Know about the Body, now in its 4th edition from Plural Publishing.

Dr. Zeller was initiated into the Mu Chi chapter of Mu Phi Epsilon at Southern Methodist University, where he was the first student ever to be awarded concurrent undergraduate degrees in Music and in Theatre. He earned M.M. and D.M.A degrees in Voice Performance with cognate studies in Opera Directing and Musicology from the College-Conservatory of Music of the University of Cincinnati while president of Alpha Alpha chapter. During that time, he was twice a winner in the Mu Phi Epsilon Musicological Research Contest and was awarded the Merle Montgomery Doctoral Grant, the Mabel Henderson Grant for Foreign Experience, and two summer scholarships by the Mu Phi Epsilon Foundation. He has been president of the Portland (OR) Alumni chapter and District Director of Pacific Northwest 3, chaired the International Committee on Standing Rules, and served two terms



as a Vice President on the International Executive Board (2003-2008, International 3rd Vice President/Alumni Advisor, and 2011-2014, International 5th Vice President/Eligibility Advisor). He chaired the committee that drafted the International Bylaws and Standing Rules adopted by the Fraternity in 2017 and served the Fraternity from 2014 to 2021 as Chair of the Bylaws Committee and Parliamentarian. He was Recording Secretary of the Atlanta Alumni chapter and Faculty Advisor for the Delta Psi chapter at Clayton State University for almost 20 years, until he was elected Mu Phi Epsilon's first male International President in 2021.

CANDIDATE STATEMENT: It has been an honor and a privilege to serve as International President of Mu Phi Epsilon for the last two years. It also has been a lot of fun—getting to see members from across our fraternity through videoconferencing and correspondence and sometimes even face-to-face visits. It has been inspiring to learn more about the wonderful work our chapters and individual members are doing everywhere, every day—and I have been proud to share that news as your representative to bodies like the National Music Council and the Professional Fraternity Association, where one of our members won their 2022 Faculty Advisor of the Year award.

I'll confess, however, that the past two years have felt a little like always running after the bus as I have "learned on the job." I now have an even better understanding of the nuts and bolts of fraternity operations than I did two years ago, and it is my hope now to put that experience to work to build for Mu Phi Epsilon a more powerful bridge from a rich and inspiring past to a strong and vibrant future. First among my priorities for the coming triennium would be working to make sure that Mu Phi Epsilon is exciting and attractive to all professionals (and aspiring professionals) in the field of music, including those whose voices have not always been heard and whose presence has not always been valued. This is not only a bridge forward, but also a link directly back to our founding in 1903, when M ϕ E was created to provide support and opportunity to musicians who had been excluded from some venues and opportunities because of their sex. M ϕ E used music, friendship, and harmony, the points of its triangle, to expand the boundaries of the circle. That still should be our mission today.

To that end, we must work to expand our membership at all levels. Put bluntly, more members mean a stronger organization—both programmatically and financially. There are many things we could do with 500 more dues-paying members that simply are not possible now. I especially want to focus on strengthening our alumni chapter network. We know that the demographic reality is that the number of traditional college-age students in the United States will decrease significantly in the coming decade—admissions officers across the country are talking about the coming "enrollment cliff" in dread tones. Welcoming and nurturing young musicians through collegiate chapters is our lifeblood and, ultimately, our primary reason for existing—but it is retention in lifelong affiliation through alumni chapters that provides the fraternity with stability and durability. Without strong alumni chapters, there is no long-term future for our beloved fraternity or for its new members. And yet, the statistics are irrefutable—for some time now, most collegiate members have chosen not to continue their active affiliation as alumni or affiliate members. We must reverse this pattern, or the fraternity will not continue. To make sure that we do so, we must create greater dialogue between



collegiate and alumni members and discover what we can do to make our young graduates as excited to join the alumni network as they were to join their collegiate chapters. I would hope that, in the coming triennium, it will be a priority of the International Executive Board to facilitate conversations throughout the fraternity about how to bridge the gap between collegiate and alumni membership—and to try to create a superhighway from one to the other.

Finally, I hope to encourage all of us to think deeply about the possibility of a new vision for the role of our convention in the life of Mu Phi Epsilon. Historically, the role of convention has been to meet triennially to conduct the business of the fraternity and to provide training experiences, and only a rather small proportion of our membership, most of it "required attendees," participates. Every three years, for this relatively sparsely attended event to conduct business, the fraternity and its members have made a massive transfer of resources from our pockets to those of the hospitality and transportation industries. I would like all of us to brainstorm about whether the current model for our triennial convention is the best possible stewardship of our resources and about how we might find ways to include in our gatherings many more members who typically have not been taking part in them. I have been hearing ideas and concerns already from chapter leaders and District Directors about this very subject for a year now—and I believe that, in the coming triennium, this conversation needs to expand to include the whole fraternity: What would it take to make our convention be the event each of you wouldn't dream of missing?

I am deeply grateful for the trust placed in me by all members of our fraternity for the last two years, and I hope to prove myself worthy of that trust for another triennium.
